COMMITMENT TO THE ERASMUS CHARTER PRINCIPLES

Declaration

I, undersigned, declare that if my institution is awarded with an Erasmus Charter for Higher Education, my institution will undertake to:

Con estas movilidades que deben ser en empresas o centros educativos se pretende conocer y desarrollar prácticas profesionales en otros países y poder trasladar las habilidades adquiridas a entornos profesionales de nuestra comunidad.

Las estancias de los estudiantes tendrán el reconocimiento en créditos ECTS correspondientes al módulo FCT (Formación en Centros de Trabajo).

En cuanto a las movilidades de profesorado se pretende que actualicen sus conocimientos prácticos en empresas y que trasladen esos conocimientos al aula para así formar al alumnado en nuevos contenidos relacionados con su práctica profesional.

Nuestro centro posee un Plan de Internacionalización donde se plasman los objetivos y acciones a realizar en los próximos años en cuanto a colaboraciones a nivel europeo.

Así mismo, nuestro centro valorará aquellas propuestas que puedan surgir de proyectos KA2 y promoverá la participación de profesorado y alumnado.

C.I. MARÍA ANA SANZ would like to carry out European mobilities of both students and teachers of Higher Education of the professional families of: computer technology, commerce and marketing, administration. Those mobilities will take place in companies and colleges and the participants will get to know and develop internships in other countries and so be able to transmit professional skills to diverse companies and colleges in our region.

Our students will be awarded with ECTS credits that will correspond to the module Training at Work Place.

As regards teachers' mobilities, we expect the practical skills of our teachers be updated so that they can transmit the new acquired knowledge and skills to their students.

Our school has developed and Internationalization Programme which reflects the objectives and actions to be taken as regards international action in the future years.

Furthermore, our school will value proposal for KA2 projects and it will promote the participation of both students and staff in future projects.

1. Los estudiantes realizarán movilidades a diferentes países de la UE para realizar sus prácticas obligatorias con el fin de obtener el certificado de Educación Superior correspondiente. Las prácticas se convalidarán como el módulo de Formación en Centros de Trabajo (FCT) y con los créditos ECTS correspondientes. El trabajo desarrollado en las diferentes empresas estará relacionado con el ciclo formativo que estén estudiando.

2.- Movilidades de alumnos en empresas de la UE como práctica complementaria una vez hayan obtenido el título de Educación Superior, tendrán certificación Europass.

3.- Movilidades de profesorado a empresas de la UE relacionadas con los módulos que imparten. De esta forma podrán aumentar los conocimientos en determinadas áreas y destrezas profesionales y transmitir dichos conocimientos a compañeros de profesión y futuros alumnos.

Todas las movilidades están recogidas en el Plan de Internacionalización de Centro.

1. Students will participate in mobilities to different European countries in order to carry out their compulsory internship to be able to obtain the corresponding Higher Education Certificate. The training period will be recognised as the module Training at the Workplace and the students will be awarded with the corresponding ECTS credits. The work carried out will be related to the professional skills of the certificate the students are taking.

2. Students will participate in supplementary mobilities once they have obtained their Higher Education certificate. Students will be awarded with Europass Mobilities for those internships.

3. Teachers and trainers will participate in mobilities to diverse companies related to the professional modules they teach. In that sense, they will update their practical knowledge in particular fields and will improve their professional skills with the objective of transmitting that knowledge to colleagues and future students.

Teniendo en cuenta el Plan de Internacionalización del C.I. María Ana Sanz, nuestro centro quiere fomentar las movilidades tanto de alumnado como de profesorado a países de la UE. Dichas movilidades servirán para reforzar tanto las competencias profesionales como las competencias lingüísticas adquiridas a lo largo del ciclo formativo del alumnado. En cuanto al profesorado, consideramos que la práctica en empresas del sector profesional supone un valor que puede ser compartido en la comunidad educativa y profesional a la que pertenecemos.

Nuestro centro colabora en la recepción y búsqueda de empresas para el alumnado y profesorado que proviene de otros países de la UE. Cabe destacar el interés de algunas empresas de la zona por contar con alumnado de movilidad Erasmus + de diversos países de la UE. Ya contamos con una bolsa de pequeñas y medianas empresas que colaboran con nuestro centro.

De acuerdo a nuestro Plan de Internacionalización, nos gustaría conseguir las siguientes metas en los próximos cinco años:

- Conseguir al menos 15 estancias formativas de 3 meses para los estudiantes por cada curso escolar.
- Conseguir al menos 2 experiencias profesionales del profesorado en cada curso escolar.
- Proporcionar al menos 5 estancias formativas para el alumnado de otros países de la UE.
- Proporcionar estancias formativas para el profesorado de otros países.
- Colaboración con diferentes centros para elaborar proyectos conjuntos.

Taking into account María Ana Sanz's Internationalization Programme, our school would like to promote European mobilities both for students and teachers. Those mobilities will enhance the professional and linguistic skills gained throughout the period of study. As regards teachers, we consider that training periods in different companies within the EU will provide the acquisition of knowledge and skills that can be shared within the educational community and the professional fields our school belongs to.

Our school collaborates in the reception and search of companies for students and teachers coming from other European countries. We would like to highlight the interest of some local companies to host students from European mobilities. We have a list of small and medium companies which collaborate with our school in the reception of mobility students.

Following our Internationalization Programme we would like to achieve the following goals in the next five years:

- Achieving at least 15 internships with a duration of 3 months for our students each school year.
- Achieving at least 2 internships with a duration of a minimum of 2 weeks for our teachers each school year.
- Getting at least five internships for students coming from other European countries.
- Providing internships for teachers coming from other European countries.
- Collaborating with different schools and colleges

Dado que nuestro centro participa en un consorcio de Grado Superior con Carta de Calidad promovido por el Gobierno de Navarra, seguiremos las instrucciones que se marquen desde el coordinador del Consorcio y procuraremos una rápida adaptación a estos sistemas telemáticos que facilitarán la gestión de la documentación y la comunicación con los estudiantes que participen en actividades de movilidad transnacional.

Además nuestro centro cuenta con un proyecto propio para movilidad de estudiantes de Grado Superior y por lo tanto, atenderá con prioridad las indicaciones del SEPIE con respecto a la puesta en marcha de las herramientas digitales que se van a lanzar con el nuevo programa.

Los representantes del centro o coordinadores del proyecto asistirán a las reuniones que organice la Agencia Nacional para tener información de primera mano y poder poner en marcha la adaptación de estos nuevos sistemas desde el primer año de su implementación.

Our school will implement the use of the new European Student Card on the dates set by the National Agency (SEPIE) making sure the accessibility by the students to the electronic applications that new program will offer.

Our school will try to follow the proposed calendar:

- 2021 – to manage inter-institutional agreements and online learning agreements
- 2022 – to send and receive student nominations and acceptances
- 2023 – to exchange transcripts of records related to student mobility

Due to the fact that our school participates in common programmes of Higher Education mobility together with the Government of Navarra, we will follow the instructions of our coordinator (the Goverment of Navarra) and we will ensure a rapid adaptation to the telematic ways for the management of documentation from our students and communication with mobility participants.

Furthermore, our school has its own mobility Project for Higher Education and will implement the new digital applications of the new programme.

The Responsible of Internasionalitation of our school will attend the meetings held by the National Agency (SEPIE) in order to gather essential information and be able to use the new applications from the very beginning.

Please explain how your institutions will implement and promote environmentally friendly practices in the context of the Erasmus+ programme.

Dado que las principales actividades que pueden llevar a cabo los estudiantes en sus prácticas formativas están relacionadas con las empresas de su sector profesional, el centro y el Gobierno de Navarra priorizarán como empresas colaboradoras a aquellas que cumplan alguno de estos requisitos:

- Empresas que cumplen con la ISO 14001 Medioambiental
- Empresas que fomenten la economía circular y los procesos de promoción del uso de energías limpias.
- Empresas que tengan entre sus objetivos transversales la preocupación por el reciclaje y la conservación del medio ambiente.

As the main tasks that are students can put into practice during their internships are related to their professional field, our school and the Government of Navarra will prioritise those companies that comply to at least one of the following requirements:

- Companies with comply with ISO 14001 Environmental.
- Companies that promote circular economy and use of clean energy.
- Companies whose transversal goal is recycling and the preservation of the environment.

Los programas de formación en los que el centro va a participar, tanto con alumnos como con profesores, estarán vinculados a otros aspectos de carácter social y cultural que promueva el conocimiento de otras personas, de otras culturas. En definitiva, no se pretende que los estudiantes o el profesorado actúe de forma individual, sino que comparta sus experiencias con otros estudiantes o profesores de diferentes países.

Nuestro centro como receptor de alumnado y profesorado de movilidad europea, además de buscar empresas para que realicen su prácticas formativas, organizará encuentros entre alumnos, visitas culturales, actividades lúdicas, viajes a lugares de interés histórico. Dichas actividades quieren promover el intercambio cultural entre ciudadanos

europeos y que los alumnos conozcan las valores de la cultura europea.

The training programmes in which both students and teacher will take part will focus on socio-cultural aspects that will promote interaction between people from diverse cultures. We would like our students and teachers to share their experience with participants from different countries.

Our school as host of students and teachers from European mobility, apart from searching for companies for internships, will also organise meetings with visiting students and staff from abroad and from our school. Those students and teachers will also participate in cultural visits, leisure activities, trips to historic sites, promoting that way cultural exchange among European citizens and the knowledge of European values.

2.2 When participating in Mobility Activities - After mobility

Nuestro centro organiza movilidades de dos tipos para el alumnado:

1.- Por un lado, aquellas que facilitan la realización del módulo de FCT en una empresa de otro país de la Unión Europea. En este caso, los estudiantes reciben el reconocimiento de 22 créditos ECTS que les permiten obtener el Título de Técnico Superior en una Actividad Profesional. Además, tendrán la certificación Europass, que les emitirá el centro Educativo y que validarán tanto desde las Autoridades Regionales como desde la Agencia Nacional.

2.- Por otro lado, se llevarán a cabo movilidades para graduados que fomenten el conocimiento empresarial y la experiencia en un campo profesional. En este caso, los estudiantes conseguirán una certificación de la empresa y la emisión del Certificado Europass Mobility, donde se registrará toda la actividad llevada a cabo en la empresa de acogida durante el periodo de formación.

Our school organises two kinds of mobilities for students:

1.- On the one hand, students fulfil their module FCT (on the Job Placement or Internship) in a company in another European country. In this case, students are awarded with 22 ECTS credits which are necessary to obtain their Higher Technician Certificate in a particular professional field. On top of that, students will be given the Europass certification that will be validated by school, regional authorities and the National Agency for Erasmus Mobilities (SEPIE).

2.- On the other, already graduated students will carry out mobilities in order to get to know other European companies and get experience in their professional fields.
